Overlength Page Charge Agreement

Overlength pages are charged to both discourage verbose papers and recover expenses for papers that are too long, because IEEE charges the Instrumentation and Measurement Society (IMS) <u>per page</u> for editing, composition, administration, and other processing costs. As such, the free page limit for the IEEE Transactions on Instrumentation and Measurement (IEEE TIM) is as follows:

Regular papers:eight (8) pagesSurvey/Review papers:twelve (12) pagesShort papers:two (2) pagesSpecial Section papers:eight (8) pages, unless stated otherwise by the Special Section

<u>For each page or fraction thereof</u> beyond the above-mentioned free page limit, there is a mandatory overlength page charge of <u>\$265 for non-IMS members</u>, or <u>\$220 for IMS members</u>. Membership is checked at the time of invoicing.

I understand that, should my paper be accepted and go above its overlength limit, I will be invoiced directly by the IEEE during the publication process of the paper. I further understand that these overlength charges will not be waived, under any circumstances, by IEEE TIM.

I also understand that the exact number of pages of an accepted paper will only be determined by the IEEE, after IEEE's editing process of that accepted paper, and not before. As an approximation (not exact!) three double-spaced, l2-point font, 26 lines per page, typewritten pages will make one printed page. Approximately six single-column figures having a 1:1 aspect ratio will fit into one printed page. Authors may wish to format their paper using the IEEE double-column format to obtain a closer estimate of the number of pages.

This Overlength Page Charge Agreement MUST be signed by an author in the position of authority whose signature commits him/her or his/her institution to the above terms. This form CANNOT be signed by an author without financial authority, such as most students.
